Establishing the position of County Executive was a key provision of the County Charter approved in 1937. It marked the separation of the legislative and executive power within the county government and placed administrative authority and functions under the head of an elected county official. Prior to January 1939, when this new charter went into effect, all executive functions had been performed by the Board of Legislators.

The County Executive operates a government similar to those at the federal, state and municipal levels. The Deputy County Executive functions as his chief assistant and deputy. County commissioners and department heads report directly to the executive through his deputy. Multiple divisions function within the County Executive's Office covering areas such as affirmative action, commerce and economic development, consumer protection, fire services, operations, personnel, women and youth. In addition there are numerous citizen advisory boards, councils and committees reporting to the County Executive.

The County Executive is elected for a four-year term and serves as the county's chief administrative officer.
