**Established:** October 1974 consisting of 5 members appointed for 5-year terms by County Executive with confirmation by County Board of Legislators

**Reorganized:** 1981 5 members appointed by County Executive to serve at his pleasure with confirmation of County Board of Legislators

**Restructured:** 1993 7 member board appointed by County Executive and confirmed by Board of Legislators (did not function during restructuring)

Oversight for this Board have alternated between the Law Department (1984-1993; 2011-) and the Department of Human Resources (1994-2010) (Information on departmental oversight prior to 1983 not located).
