**Established:** 1934, by the Commissioners of the Westchester County Emergency Work Bureau, to advise the staff of the County Planning Survey Project

**Abolished:** 1936, upon completion of the survey project

The County Planning Survey Project had as its purpose the collection of information on the growth of the County in a variety of physical and economic fields, and the collection and analysis of fundamental information concerning the growth and trends of development in the County. The Advisory Committee consisted of both citizens and technicians, the latter who acted as individuals yet through their vocations were familiar with the County's problems.

At least one member was to have been a licensed professional engineer.

The Westchester County Planning Board at full complement consists of 12 members who serve staggered three-year terms. Nine of the members are private citizens, appointed by the County Executive and confirmed by the Board of Legislators. By law, four of the nine must be residents of any four cities in Westchester; two must be residents of any two county villages; and three must be residents of areas outside any city or village.

The remaining three members, voting and ex-officio, are the Commissioners of the Departments of Environmental Facilities, Public Works, and Parks, Recreation and Conservation [*note see those Record Group Listings for names of ex officio members if not listed for any given year*]. A quorum consists of seven members – an absolute majority of the fully authorized membership of the board.

The County Executive appoints the Board Chair. The board members elect the Vice-Chair. Ad hoc committees are formed depending on issues being studied by the board.

## ENVIRONMENTAL MANAGEMENT COUNCIL (RG13)

**Authorized by:** Resolution 167-1977

The Environmental Management Council is a focal point for the citizen environmental advisory role in county government. The duties of the council are to: Provide environmental information, advice, assistance and training; review and comment on pending actions within the county which have environmental implications; advise county government on environmental protection policies and sound use of natural resources; prepare reports, maps and publications; and maintain a database and library

**Council membership:** The council is made up of the following major groups: (1) Representatives from municipal citizen conservation councils and boards. Municipalities without a council or board may appoint a representative to the EMC; (2) Representatives from county government advisory boards of Health, Parks and Planning; (3) Members-at-large appointed for their special interest or qualifications; (4) Commissioners of the departments of Environmental Facilities, Health, Parks, Planning and Public Works; (5) Soil and Water Conservation District Board of Directors; (6) Representative from the County Board of Legislators

The council meets at least four times per year to discuss issues of interest to the general membership.
